

Contract-offer

AURA-SMART website Terms & Conditions

1. General provisions

1.1. "AURA-SMART", further, the "Seller" publishes an Offer to the general public for the sale of goods, based on the samples, presented on the Seller's official website <https://aura-smart.org/>

1.2. In accordance with article 437 of the Civil Code of Russian Federation (CC RF), this document is an offer to the general public, and if the conditions below are accepted, the citizen who accepts this offer will pay for the Seller's Goods in accordance with the terms of this Contract. In accordance with paragraph 3 of article 438 of the Civil code of Russian Federation, payment for Goods by the Buyer is an acceptance of the offer, which is considered equivalent to entering into the Contract on the terms set out in this Offer.

1.3. Based on the above, carefully read the text of this Offer to the general public, and if you do not agree with any point of this Offer, you are invited to refuse to purchase Goods or use the Services provided by the Seller.

1.4. In this Offer, unless the context requires otherwise, the following terms have the following meanings: • "Offer" – a public offer of the Seller, addressed to any citizen, to conclude a sales contract with him (hereinafter-the "Contract") on the existing terms contained in the Contract. • "Buyer" – a citizen who has concluded the Contract with the Seller on the terms contained in the Contract • "Acceptance" – the Buyer's full and unconditional acceptance of the terms of the Contract. • "Goods" – a Pricelist, presented on the official website. • "Goods order" – items from the Pricelist, presented on the official website. • "Delivery" - services for Goods order delivery.

2. The subject of the contract

2.1. Seller sells Goods in accordance with the current pricelist, published on Seller's website "<https://aura-smart.org/>", and Buyer makes the payment and receives Goods in accordance with the terms of this Contract.

3. Goods order registration

3.1. Goods is being ordered by the Buyer via <https://aura-smart.org/>.

3.2. When registering on the Seller's website, the Buyer undertakes to provide the following registration information about himself: • last name, first name, • actual delivery address; • email address; • contact phone number.

3.3. Buyer is responsible for the accuracy of the information provided while registration Goods Order.

3.4. The Order payment date is the date of conclusion of the sales contract between the Seller and the Buyer.

3.5. All information materials provided on <https://aura-smart.org/>, are for reference only and cannot fully convey reliable information about certain properties and characteristics of the Goods. If the Buyer has any questions regarding the properties and characteristics of the Goods, he should consult the Seller before registration an Order.

4. The terms of the Goods Order

4.1. The Order execution Period depends on the availability of the ordered items In the Seller's warehouse and the time required to process the Order. The Seller undertakes to notify the Buyer of changes in the completeness of his Order.

4.2. The Order is considered delivered at the time of its transfer to the Buyer. By signing the courier list, the Buyer confirms the Order execution.

4.3. If the Buyer provides false information about his contact details, the Seller is not responsible for improper execution of the Order.

5. Goods Order Payment

5.1. If we are unable to contact You, the order will be treated as cancelled and if You have already paid for the product(s) You will receive a full refund.

We are under no obligation to sell the product(s) to You at the incorrect (lower) price (even after we have sent You an Order Confirmation) if the pricing error is an obvious typographical or arithmetical inaccuracy and could have reasonably been recognized by You as such.

The prices displayed on our website include VAT.

We reserve the right to decline orders for bulk or high value purchases and to change price and availability information without notice.

Once You have finished shopping all the items You wish to purchase are added to your basket. Your next step will be to go through the checkout process and make payment. To do this:

- Click the "Shopping bag" button at the top of the page.
- Click on the "Checkout" button.
- Fill-in or check your contact details, the details of your order, the delivery address and the invoicing address.
- Fill in your credit card details.
- Click "Authorize payment"

Payment can be made by Visa, MasterCard, PayPal. We use «Tinkoff bank» and PayPal to ensure payment is made safely and your Card details will be encrypted to minimize the possibility of unauthorized access or disclosure. Authority for payment must be given at the time the order is made. By clicking "BUY NOW" You are confirming that the Card is yours. The amount authorized by You will not be taken until your order is dispatched for delivery. If payment is made via PayPal the amount will be charged upon confirmation of your order.

Cards are subject to validation checks and authorization by your Card issuer. If we do not receive the required authorization, we will not be liable for any delay or non-delivery.

6. Delivery of the Goods.

6.1. The Seller's Obligation to deliver the Goods with the condition of its delivery is considered fulfilled from the moment the Buyer signs the shipping documents.

6.2. The right of ownership of the Goods and the risks of accidental damage and/or loss of the Goods pass to the Buyer from the moment of actual transfer of the Goods and signing of the shipping documents upon delivery of the Goods to the Buyer.
